Eligibility Criteria

You must:

- 1) Be 60 years of age or over.
- 2) Have **NO** employment income or rental income in 2023.
- 3) Have an annual income of less than \$1000.00 (RRSP/RRIF or other investments) with the exception of the income accrued from OAS / GIS / CPP / OW / ODSP.

*** *We do not prepare complicated tax returns for clients who are deceased, whose spouse has passed away, or have a separation/divorce in 2023*



To complete the Tax Return Form, YOU MUST BRING the following documents:

- 1) Government I.D. with photo (such as Health Card or Driver License etc.)
- 2) Social Insurance Card (S.I.N.);
- 3) Year 2022's copies of the T1 General/ NOA (Notice of Assessment);
- 4) Current Year's Tax Form and other Tax Slips sent by government ;
i.e. T4A (OAS), T4A (P), T4E, T5007 (Social Assistance payment) etc.
- 5) Interest Income i.e. T5 Slip or Bank Book (if interest amount is less than \$50);
- 6) Investment or RRSP i.e. T3, T4RSP, T4RIF;
- 7) Proof of rental payment or property tax payment e.g. Bank Book, annual rental receipt,
annual property tax statement etc.
- 8) A VOID cheque for direct deposit use.

- 利息收入證明: 如利息年結即 T5 或 銀行存摺 (如利息少於\$50);
- 投資及退休儲蓄計劃,包括 T3, T4RSP, T4RIF;
- 租金或物業稅證明如全年租金單、銀行存摺、全年物業稅單(必須是能顯示整年物業稅的稅單)等;
- 一張銀行支票 (如需自動轉帳)
